## **PAC MEDIA STATEMENT ON PROCEEDING OF THE MANAGEMENT OF THE IMPLEMENTATION OF THE MULTI-LANE FREE FLOW (MLFF) TOLL SYSTEM**

1. The Public Accounts Committee (PAC) agreed to hold proceedings regarding the management of the multi-lane free flow (MLFF) toll system's implementation done by the Ministry of Works.
2. It was unanimously agreed among the PAC members during a special meeting at the Parliament and the Committee will conduct the proceedings based on the Dewan Rakyat's Standing Order 77(1)(d), Treasury Instruction 301 Year 2023, and Section III Article 11(b) General Circular No. 2 (1982).
3. Besides the highway operators involved in the implementation of the MLFF, the Ministry of Works and the Malaysian Highways Authority (LLM) will also be summoned for the proceedings.
4. The Committee will start the proceedings on MLFF in the first week of the Dewan Rakyat session.
5. On other matters, PAC had finished the proceedings of all the seven(7) issues selected from the Auditor General's Report Year 2022.

6. Those issues are the Langkawi Development Authority (LADA)'s Management of Property Development, Integrated Foreign Workers Management System (ePPAx) and Foreign Workers Centralised Management System (FWCMS), UiTM Holdings Sdn Bhd, Forest Management and Environmental Impact, National Flood Forecasting and Warning Programme; and Management, Upgrading and Redevelopment of Dilapidated School Buildings.
7. PAC is of the opinion that it had fully completed the proceedings of these three issues, namely the LADA's Management of Property Development, UiTM Holdings Sdn Bhd, and the National Flood Forecasting and Warning Programme.
8. Meanwhile, proceedings of four other issues will continue with follow-up proceedings as the Committee views that it still needs to hear from the Ministries concerned their explanations for the topics involved.
9. At the same time, PAC will conduct a working visit to Sarawak and Sabah to inspect the dilapidated school buildings there to complete its probe into the issue on the Redevelopment of the Dilapidated School Buildings.
10. PAC is committed to tabling all the reports during the First Meeting of the Third Session of the Fifteen Parliament, which will commence on 26 February 2024.
